REPORT

Fire Season of 1939

131

The 1939 fire season started the latter part of April and in spite of light, intermittent rains there was fire danger throughout the entire summer, and it was necessary to maintain some patrols during the whole month of. October.

For the last seven years the Association has been able to work with the income from three assessments, but the prolonged dry season made it necessary to ask for the fourth assessment in 1939. There were twelve fires reported, burning a total of twenty-five acres, mostly brush and cut-over lands. The Success fire of August 15th was the most expensive, although only a small area was burned over. Due to the fact that one of our patrolmen reported it almost immediately we were able to prevent a very disastrous fire as there were several thousand cords of cut pulpwood very close to the start of the fire.
